Bids must be submitted in sealed envelopes clearly marked “TENDER NO: ALF5-25/26-0009: “SUPPLY AND INSTALLATION OF GALVANISED STEEL PALISADE FENCING” must be deposited in the bid box, at the Department of Public Works & Infrastructure, Cnr Nkosi Senyukele & Ngqubusini street, off Ntsizwa street, Mt Ayliff, 4735 not later than **11h00 am**.

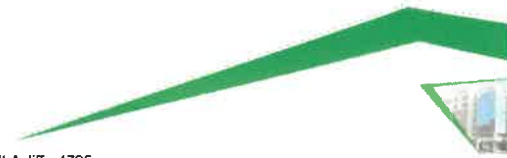
