The Eastern Cape Department of Public Works & Infrastructure invites Contractors with a CIDB Grading of **2SF OR HIGHER**.

The contract will be based on GCC Third Edition 2015.

Only tenderers who have suitable experience and suitably qualified personnel in providing similar services to those that are required are eligible to submit tenders.
